

Village of New Hartford's

2021 Municipal Waste Collection Guideline

Weekly Garbage Collection

Collected Monday and Thursday Night at curb by 10:00 PM

- Garbage containing recyclables will not be collected.
- Garbage must be in cans or heavy duty plastic bags. No 55 gallon barrels.
- ♣ No hot ashes allowed.
- No hazardous liquids (oil, antifreeze, cleaning products, paint). Empty paint cans are allowed. 50 pound limit per can or bag.
- Heavy commercial, industrial, medical and special waste will not be collected by Village crews.

Green Waste: May 16th - September 30th

Collected Wednesday at curb by 7:00 am

- Leaves, grass clippings, and hedge clippings must be in metal or plastic cans.
- ♣ No plastic bags allowed.
- Limbs must be tied in bundles no more than 6 foot in length and 18 inches in diameter. Pile limbs parallel with curb to minimize lawn damage during collection.
- Individual limbs not to exceed 6 foot long or 12 inch in diameter.
- No stumps allowed.
- ♣ Do not pile in roadway.
- Tree removal contractors must remove their waste.

Weekly Recyclable Collection

Collected Wednesday Night at curb by 10:00 PM

Refer to your Oneida Herkimer Recyclable Flyer for listing of recyclable products.

Green Waste: April 1st – May 15th & October 1st – November 15th

- ♣ Due to the large volume of green waste during this period, no specific collection day can be given.
- ♣ Each street collected once weekly.
- ♣ Loose leaves will be collected between the sidewalk and the curb.
- ♣ No leaves in plastic bags.
- ♣ If you prefer to contain waste, use cans only.
- ♣ Brush and vegetation will be collected but must be kept separate from leaf piles.
- 🖶 Do not pile material in roadway.

Please follow limb set out guideline as detailed in May 16th – September 30th description.

Bulk Trash and Junk Disposal Options

Waste Category Examples

Waste must be separated as described below:

- **A.** <u>Construction and Demolition</u>: Wood and lumber tied in bundles not exceeding 8 feet long by 18 inches in diameter, plaster and shingles in containers, porcelain sinks and toilets, storm windows and doors.
- **B.** Sanitary Waste: Clothes, mattresses, stuffed-furniture, toys, televisions, and rugs.
- 4 C. Metals: Pipe not exceeding 8 feet long, tire-rims, bikes, cast tubs and sinks, washers, dryers.
- **D.** Appliances Containing Refrigerants: Refrigerators, freezers, dehumidifiers, A.C. units. Limited to 1 per collection.
- **E.** <u>Tires</u>: Dismounted from rims, 16 inch or less, no tractor or heavy truck tires collected. Limited to 6 tires per collection.
- F. Hardfill: Stones, dirt, rocks, 1 cubic yard per collection.

Disposal Option # 1: Curbside Collection

Collected on the <u>second Monday</u> in May and October at curb by 5:00 am

Category collected: A, B, C, D, E, F

Collection limits for category A, B, C, are limited to 4 foot wide by 8 foot long by 3 foot high each.

Collection limit for category D is one each.

Collection limit for category E is six tires.

- ♣ Only one collection per category per street.
- Material must be sorted and contained as specified in category description.
- ♣ No batteries, paints, or liquids will be collected.

Do not pile material in roadway.

Disposal Option # 3 Village Dumpster Rental

You may rent a dumpster delivered to your residence for large cleaning jobs or homeowner remodeling projects for these wastes: green waste, construction debris, sanitary waste, and hardfill. This service is for residential use only to supplement our regular schedule and to provide a fair method to pay for the disposal cost of large quantities of waste. Call the DPW for the current price schedule.

Disposal Option # 2: Drop Off at Dumpster at DPW Garage at 2 Mill Street

The <u>second Saturday</u> of April, June, July, August, September, and November.

- ♣ Open from 8:00am 4:00pm.
- **♣** Categories accepted: A, B, C, D, E

The <u>second Saturday</u> of December, January, February, and March

- ♣ Open from 8:00am 12:00pm.
- Categories accepted: B, C, D, E

For Village residents to bring categories listed to DPW garage for disposal. An attendant will be present to aid loading and verify proof of residency.

Disposal Option # 4: Private Waste Hauler

This option should be used for large amounts of waste, contractor waste, or if you need multiple dumpsters. Check phone book for listings.

- ♣ Christmas trees will be collected at the curb January 1st through January 31st.
- Compost is available free of charge while supplies last and can be picked up outside the old Village brush dump located at the end of Graham Ave. Bring a shovel and a container.

Household Hazardous Waste Disposal

The Oneida Herkimer Solid Waste Authority provides a drop off site for county residents to dispose of household hazardous wastes per Authority schedule, policy and volume limits. Some examples of these wastes are: motor oil, antifreeze, gasoline, auto batteries, empty propane cylinders, paint, thinners and solvents, pool chemicals, herbicides, pesticides, and glues. HERE'S HOW IT WORKS

★ All Recyclable Items Mix Together In One Bin For Collection ★

- 1. All recyclable items—paper, plastic, metal and glass—need to be mixed together loosely in one container.
- 2. Recyclables must be placed in an approved container no less than 10 gallons, not more than 35 gallons.
- 3. Lids and labels should be left on recyclable containers. Containers should be empty and rinsed before recycling.
- 4. Do not place recyclables in plastic bags for collection. No string, trash or green waste allowed.
- 5. Cardboard boxes must be empty (packaging removed) and flattened/broken down before recycling.

★ ONLY ONE EXCEPTION TO THE RULE: SHREDDED PAPER – PLACE IN A CLEAR PLASTIC BAG WITH YOUR RECYCLABLES ★

Items That **SHOULD NOT** Be Placed In Your Recycling Bin

- Sharps
- Do not set out with your recyclables! Place used needles, syringes and lancets in a puncture-proof plastic container like a laundry detergent bottle with a top. When full, tape lid/top shut, label as "sharps" and place in the garbage.
- Plastic Bags
- Batteries
- · Ceramics
- Clothes Hangers
- Drinking Glasses
- Electronics
- Garbage
- · Household Hazardous Waste
- · Lawn & Yard Waste
- Light Bulbs
- Paint Cans
- Propane Tanks
